



Information for Minority Messengers

Rules regarding photographs, videos or other visual/audio content:

You cannot just take pictures of people and post them online. It is legal, but it is also not fair and nice.

However, of course, we would be very happy to receive some photos and visual documentation from your Minority Messenger visit.

In order to follow the rules, we need to have the consent of the people who are on the photographs, videos or other visual/audio content. For that we prepared a list, which can be signed, and which makes it safe for us, to use the photographs of the people, who are o.k. with that and signed the list. (To use the list, you can simply print the following 2-3 pages and take it to your visit).

It is mentioned in list, but again, just to make sure: we use the pictures ONLY for the purposes of YEN - for the promotion of organisation and documentation. We never sell the pictures or give them to any companies who might use them for their advertisement etc.

We know it takes a bit of effort, and if you don't feel comfortable, then there are some alternatives:

- take pictures where people are not to be recognized e.g. pictures of hands, from the back, picture of the materials, of the feet etc it can get pretty creative!
- maybe if pictures are complicated, you could interview somebody after the visit and record it? For that we also need a consent (same list applies), but people might be a bit more comfortable with that
